Spotlight: ZORC. An Interview with Annville Township Commissioner Jim Scott on the Work of the Zoning Ordinance Review Committee

As the happy melodies of nesting songbirds and the hum of lawn mowers fill the air with the sounds of spring, we're only days away from this year's 26th Annual Historic Old Annville Day on Saturday, June 13, which promises to be bigger and better than ever. Hope you can make it! See the pullout inside this edition of the *Landmark* for more details.

Other recent happenings include Annville Township's preliminary approval of Harrisburg-based PinnacleHealth's plans to revamp and expand the Annville East Center at 1251 East Main St. (with bike and pedestrian paths and other tweaks added at the commissioners' insistence); Williams Partners' filing with the Federal Energy Regulatory Commission for its proposed underground 42-inch, 1,480 p.s.i. natural gas pipeline, despite not specifying a precise path through the pipeline's bottleneck at Route 422 near Annville Township's recently upgraded Wastewater Treatment Plant; the upcoming Phase 2 of the Quittie Creek Streambank Restoration project; and much else.

But here I'd like to spotlight the work of what is probably, for most Friends of Old Annville, an obscure and shadowy group, but what is in fact a merry little band of hard-working volunteer public servants whose work will shape Annville's future in important and enduring ways: Annville Township's Zoning Ordinance Review Committee, or ZORC. In what follows we delve into the mysteries of ZORC via the following interview with one of the committee's co-chairs, Annville Township Commissioner Jim Scott. (Other members of ZORC, a.k.a. ZORCians, are Zoning Hearing Board member and ZORC co-chair Fred Richter, Township Commissioner Rex Moore, Township Administrator Nick Yingst, Zoning Hearing Board member Marty Brandt, and Planning Commission member Millie Kish.)

Q: COULD YOU GIVE US A BRIEF HISTORY OF ZORC'S WORK AND GIVE US A SENSE OF WHY IT MATTERS?

A: "The Committee began its work in January 2014, and since then has met three Thursdays each month from noon to 4:30 PM. We are working through a 2008 draft of a revised zoning ordinance prepared by Township engineers to replace the ordinance currently in force, which was adopted in 1983. (The draft is available on-line from the Township website, www.annvilletwp.com; the current ordinance may be downloaded from the same site.) We review this document line by line, sometimes word by word, with the goal of crafting a document that respects the reality of Annville's situation—a town from the 1763 that has developed continually through more than two and a half centuries—and seeks to preserve its historic character while allowing

for future growth and positive change. Zoning came about in the early 20th century to regulate development and preserve property values (New York City passed the nation's first comprehensive zoning code in 1916). The basic notion presumes that birds of a feather should flock together. Our work matters because zoning is by nature an intrusive regulatory practice mandating what individuals can and cannot do with their property for the greater good of the entire community. As we review the proposed regulations, we call upon our collective experience with life in town, the various requests over the years for variances and relief from current zoning restrictions, and best practices other communities have adopted for dealing with current and anticipated developments."

Q: GIVE US AN EXAMPLE OR TWO OF SOME OF THE MAIN ISSUES AND CHALLENGES ZORC HAS FACED AND HOW IT ENDED UP RESOLVING THOSE ISSUES.


A: "One large issue is the presence of Lebanon Valley College. Until now, each new development has typically required a number of variances. Our revision will propose an institutional zone which will give the College the right to adapt and build according to its needs and an institutional overlay on College owned properties that border the community. The overlay provides for certain uses not permitted in the underlying zone, but requires review and approval by the Zoning Hearing Board; it is intended to provide a buffer for development between College-owned properties and the residential district in which they are located.

"Another large issue was signage. Signs are necessary accouterments to civic life: they inform, direct, regulate, and advocate; but they can also distract, disfigure, devalue, and clutter. We found the current ordinance confusing and outdated. We responded with two, user-friendly charts: one for the purpose of an intended sign and another for its form. The charts then give details for the size and location of signage intended for each of the various districts."

Q: WHAT DO YOU SEE AS SOME OF THE MAIN CHALLENGES AHEAD?

A: "One huge challenge will be rereading and final editing of the entire document. We will be looking for consistency of style, accuracy and transparency in the organization. Another will be the public rollout of the completed document. Part of our process has been to send sections to our Zoning Officer (Lebanon County Planning Department) for review as we complete them. But we will post the entire document online and hope for energetic participation by members of the community who will have to live with what we have proposed once it is adopted. The more eyes we have on this project, the more likely we are to arrive at a document that will help shape Annville's development in a good way for at least the next generation, if past experience is any guide."

ZORC expects to finish its work by this coming fall. We are grateful for the efforts of the hardworking volunteers comprising the ZORC, and encourage all community members to heed Commissioner Scott's advice and review this emerging document − one that promises to shape Annville's future for many years to come. ■


QUARRY TOURS

Quittie Park Summer Program on Saturday, June 20 at 8 AM
