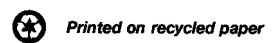

**Explanation:** Friends of Old Anville, Inc. oversaw the financing and construction of a pedestrian bridge over the Quittapahilla Creek within the Quittie Creek Nature Park in Anville Township, Lebanon County, Pennsylvania. While the park is owned by Anville Township, a subcommittee within our organization has carried out volunteer park maintenance for approximately 18 years. That committee of Friends of Old Anville, the Quittie Creek Nature Park Committee, agreed with Anville Township to work with the Pennsylvania Department of Transportation to set up a PENNDOT-funded project to construct a foot bridge to connect Anville Township and South Anville Township, with the understanding that our organization would transfer ownership of the bridge to Anville Township upon completion of the project. We were able to secure PENNDOT funding for construction costs, as well as a Pennsylvania Department of Community and Economic Development(DCED) grant of \$55,500 to cover engineering and other costs associated with construction. The bridge was largely completed in 2007, and fully completed in 2008. Ownership of the bridge was legally transferred from Friends of Old Anville to Anville Township on May 5, 2008. Along the way, PENNDOT money was released only after invoices from the contractor (Lech Brothers Construction Corp.) were received and approved: the payments went to Friends of Old Anville and which, in turn, paid the contractor the same amounts. The amount of PENNDOT funds so processed in 2007 was \$73,319.66. We did count the PENNDOT funds on Form 990, Part 1, Line 1d. We were not sure whether we needed to or not, but we did list them and that action moved our gross receipts over \$100,000. In each of the past 4 years, our organization's annual gross income has not gone above \$35,000, and we usually file Form 990-EZ. Subtracting the gross income from PENNDOT and DCED from our 2007 total gives a non-footbridge related gross income of \$12,563, a figure more in line with recent years.
